

**LIPBOLDLY SWEEPSTAKES AND INSTANT WIN GAME**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The LipBoldly Sweepstakes and Instant Win Game ("Promotion") is sponsored by Revlon Consumer Products Corporation ("Sponsor"), 1 New York Plaza, New York, NY 10004 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. PROMOTION PERIOD:** The Promotion begins on April 11, 2019 at 12:00 PM (noon) Eastern Time ("ET") and ends on May 31, 2019 at 11:59:59 PM ET ("Promotion Period"). The Promotion consists of an "Instant Win Game" and a "Sweepstakes." The Administrator's computer is the Promotion's official clock.
  
- 2. ELIGIBILITY:** This Promotion is offered only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (collectively, the "Promotion Entities") and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Promotion. Void where prohibited or restricted by law. All federal, state and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address. If it is discovered or suspected that an entrant has registered or attempted to register for the Promotion using multiple e-mail addresses or multiple identities, all of that entrant's entries will be declared null and void and any prize an entrant might have been entitled to win will not be awarded any may be revoked. Use of any automated system or any like methods to participate in the Promotion is prohibited and will result in disqualification of any entrant attempting such use.

- 3. HOW TO PARTICIPATE:** During the Promotion Period, eligible entrants must visit [lipboldly.revlon.com](http://lipboldly.revlon.com) ("Website") and provide a valid e-mail address. Entrant must then complete and submit the registration form including, but not limited to, his/her first and complete last name (no initials), phone number, street address (no P.O. Boxes will be allowed), city, state, zip code, date of birth, and agreement to these Official Rules. After registering or logging-in the entrant will automatically receive one (1) entry into the Sweepstakes and one (1) Instant Win game play ("Game Play"). Entrant must follow the on-screen instructions to play the Instant Win Game. After the Game Play, the entrant will receive notification on the Website screen as to whether he/she is a potential "Instant Winner" ("Notification"). Each entrant who receives a winning Notification will be deemed a potential

Instant Winner subject to verification of the entrant's eligibility and compliance with these Official Rules, as determined by Sponsor in its sole discretion. An entrant is not a winner of any prize, even if the Notification should so indicate, unless and until entrant's eligibility and the potential winning Game Play have been verified and entrant has been notified that verification is complete. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. Any Game Play that occurs after the system has failed for any reason is deemed a defective play, is void, and will not be honored. There is a limit of one (1) Sweepstakes entry and one (1) Game Play for registering/logging in per day.

**Additional Entries/Game Plays:** During the Promotion Period, eligible entrants may receive additional Sweepstakes entries and/or Game Plays through the following methods:

- a) **Watch a Video:** During the Promotion Period, an eligible entrant may follow the links and instructions to watch a video on the Website. Entrant will receive one (1) Sweepstakes entry and one (1) Game Play for watching the video. There is a limit of one (1) additional Sweepstakes entry and one (1) Game Play through this method.
- b) **Complete a Profile Quiz:** During the Promotion Period, an eligible entrant may follow the links and instructions to complete a profile quiz. After the quiz is complete, he/she will receive one (1) Sweepstakes entry. There is a limit of one (1) additional Sweepstakes entry, per day, through this method.
- c) **Upload a Photo:** During the Promotion Period, an eligible entrant may follow the links and instructions to upload a photograph on the Website, Twitter, and/or Instagram showing your bold lip look ("Photo"). A purchase is not required to submit a Photo. Each unique Photo may only be submitted one (1) time during the Promotion Period. Upon the successful submission of a Photo, entrant will receive one (1) Sweepstakes entry. In order to receive an entry for posting on Twitter and/or Instagram, an eligible entrant must first connect his/her Twitter and/or Instagram accounts. After connecting his/her account, the eligible entrant may post a Photo and include #lipboldly, #revlon, #sweepstakes. All three (3) hashtags must be included to be eligible in this Promotion. If posting on Instagram, entrant must also mention @revlon in the post in order to be eligible in this Promotion. Regardless of the method used to upload a Photo, there is a limit of three (3) additional Sweepstakes entries, per day through this method. Photos will not be judged but must comply with the Photo Guidelines and Requirements as set forth in Section 4 below.
- d) **Share on Facebook/Twitter:** During the Promotion Period, an entrant may obtain up to twenty (20) additional entries into the Sweepstakes by following the instructions on the Website and set forth below to share the Sweepstakes on Facebook and/or Twitter. Upon clicking the buttons to share the Sweepstakes, a message with a unique link will be posted to the entrant's choice of his/her Facebook Wall or Twitter Feed ("Invitation Post"). To obtain an entry, an entrant's Facebook "Friend" or Twitter follower must click on the unique link in the Invitation Post and complete and submit the registration information requested, and enter the Promotion. Upon the Friend's/follower's successful entry into the Sweepstakes, the original entrant will receive one (1) Sweepstakes entry. An entrant will receive one (1) entry for each Friend/follower who enters the Promotion by following the unique link in his/her Invitation Post, up to maximum of ten (10) total entries for Facebook and ten (10) total entries for Twitter.
- e) **Enter a Code:** During the Promotion Period, Sponsor will post a code on the Revlon Social Accounts. Eligible entrants may enter the code on the Website to receive one

(1) Sweepstakes entry and one (1) Game Play. There is a limit of one (1) code entry per week through this method. A week is defined as starting on a Thursday and ending the following Wednesday, except the last week which will start on Thursday, May 30, 2019 and end on Friday, May 31, 2019.

- f) **Write a Review:** During the Promotion Period, eligible entrants may purchase a qualifying product and then click a link and go to the Sponsor's website to write a product review. Sweepstakes entry will be awarded upon entrant clicking the link, regardless of if they submit a review. Entrant must include the email address used when registering for this Promotion. **Each review must also include #sweepstakes to be eligible to receive an additional entry and must disclose that they are writing a review for purposes of entering the Promotion.** Entrant will receive one (1) Sweepstakes entry after clicking the review link. There is a limit of one (1) additional Sweepstakes entry through this method. To receive an additional entry without submitting a product review, entrant may submit a mail-in entry request per the instructions set forth in Section (i) below.

**Mail-in Method of Entry:** To receive additional entry without submitting a product review, an eligible entrant may hand-write his/her complete first and last name (no initials), valid e-mail address, valid street address (P.O. Boxes not accepted), city, state, zip code, telephone number, and date of birth (MM/DD/YYYY) on a 3½"x5" card ("Mail-In Request") and mail it with sufficient postage to: The Lipboldly Sweepstakes & Instant Win Game (PL11822), P.O. Box 251328, West Bloomfield, MI 48325. Entrants who submit a Mail-In Request will receive one (1) additional entry into the Sweepstakes. There is a limit of one (1) Mail-in Request per person during the Promotion Period. All Mail-In Requests must be postmarked by May 31, 2019 and received by June 10, 2019, in order to be eligible.

Mail-In Requests must be legibly hand-written by entrant. Mechanical reproductions, postage-due, Mail-In Requests mailed in an envelope or sent in excess of the entry limits set forth below will not be accepted. Mail-In Requests received without a verifiable and legible return address will be deemed incomplete and not valid entries.

**LIMIT:** Regardless of the method, or combination of methods used to enter the Promotion, an entrant is limited to receiving no more than the stated number of Sweepstakes entries/Game Plays during the entire Promotion Period. If more than the stated number of entries/Game Plays are received from the same person, telephone number and/or e-mail address during the Promotion Period, the entries may, at the Sponsor's sole discretion, be disqualified.

For purposes of this Promotion, a "day" is defined as starting at 12:00 AM (midnight) ET and ending at 11:59:59 PM ET on each calendar day during the Promotion Period, except on April 11, 2019 when the day will start at 12:00 PM (noon) ET and end at 11:59:59 PM ET. In the event that a household enters the Promotion using more than five (5) unique e-mail addresses, all of the Game Plays/entries associated with that household (determined by Sponsor or Administrator in their sole discretion) may be disqualified.

If applicable, an entrant must have a non-private Twitter account or Instagram account to enter the Promotion using Twitter or Instagram and must be a follower of @revlon on the platform used for sixty (60) days after the end of the Promotion Period for winner notification purposes to be eligible to win/claim a prize. If an entrant does not have a non-private Twitter account, he/she can create one at no cost by visiting [www.twitter.com](http://www.twitter.com). Please note that an entrant must

agree to comply with the Twitter Terms of Service (<https://twitter.com/tos/>) and Privacy Policy (<https://twitter.com/privacy>) (if entering using Twitter) in order to participate in the Promotion. Entrants may create an Instagram account at no cost by logging on to <http://instagram.com>. Creation of an Instagram account requires a contestant to agree to Instagram's Terms of Service and Privacy Policy, available at <http://instagram.com/about/legal/terms/> and <http://instagram.com/about/legal/privacy/>, respectively. Due to the way Instagram operate its services, entries from users with protected or private accounts (i.e., entrant has set his/her account so that only people the entrant has approved can view his or her updates) may not be received. Use of Facebook will be subject to that service provider's privacy policy and terms of use. The Facebook privacy policy is available at: <https://www.facebook.com/about/privacy>.

This Promotion is in no way sponsored, endorsed or administered by, or associated with Instagram, Twitter, or Facebook. Each entrant specifically agrees to release Instagram/Twitter/Facebook from any and all liability associated with this Promotion. Entries will be deemed made by the authorized account holder of the account the entry is submitted from at the time of entry. The "authorized account holder" is the person who is assigned to the Instagram/Twitter/Facebook account by the online service provider.

- 4. PHOTO GUIDELINES AND REQUIREMENTS:** By submitting a Photo, entrant grants Sponsor and its agents an unlimited, worldwide, irrevocable, perpetual license and right, but not obligation, to publish, reproduce, exhibit, use, publicly display, distribute, edit, crop or otherwise exploit and create derivative works of the Photo (as well as any name or likeness embodied therein) in any way, in any and all media, now known or hereafter devised, without limitation, and without further consideration or approvals. Each entrant waives any intellectual property rights, publicity/privacy rights or other legal or moral rights relating to such use. BY SUBMITTING A PHOTO, ENTRANT AGREES THAT THE PHOTO, ALONG WITH HIS/HER FIRST NAME, AND LAST INITIAL, MAY BE POSTED ON THE WEBSITE, OTHER SOCIAL MEDIA PLATFORMS, INCLUDING BUT NOT LIMITED TO OTHER PAGES ON FACEBOOK, INSTAGRAM, TWITTER, ETC., THE INTERNET, TELEVISION, RADIO, AND PRINT AT SPONSOR'S SOLE DISCRETION, AND ENTRANTS ACKNOWLEDGE THAT THEIR ENTRIES MAY BE REPOSTED BY THE PUBLIC OR OPEN TO PUBLIC COMMENTARY, FOR WHICH SPONSOR AND THE PROMOTION ENTITIES SHALL NOT BE LIABLE.

Once an entry is submitted in the Sweepstakes it may be made available on Sponsor's social media accounts or other websites for viewing by the general public and any such posting will be deemed made at the direction of the entrant within the meaning of the Digital Millennium Copyright Act and the Communications Decency Act.

**PHOTO GUIDELINES AND REQUIREMENTS:**

- Photo must be in one of the following formats: .JPEG, .JPG, .GIF, or .PNG;
- Photo must not exceed 8 MB;
- Must not contain material that violates or infringes another's rights, including, but not limited to, privacy, publicity or intellectual property rights, including copyright infringement, or legal or moral rights of any third party, living or deceased;
- Must not disparage Sponsor, Administrator or any other person or party affiliated with the promotion and administration of this Promotion;
- Must not include any personally identifiable information;
- Must be the original work of the entrant and must not contain images or artwork,

- music, quotes, parodies or other materials not created by entrant;
- Must not feature brand names, logos or trademarks other than Sponsor’s trademarks in any other element of the entry or image, which Sponsor has granted, as respect to the Sponsor’s trademarks, entrant a limited license to use for purposes of this Promotion;
- Must not have been submitted previously in a promotion or contest of any kind and has not been exhibited or distributed currently or previously in any media;
- Must not contain, facilitate, reference, or use material that is fraudulent, inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, slanderous or libelous;
- Must not contain, facilitate, reference or use material that contains prohibited content which shall include, but is not limited to content that promotes, suggests, or encourages:
  - i. gambling, including without limitation, any content related to online casinos, sports books, bingo or poker;
  - ii. the use of firearms/weapons/ammunition, any illegal drugs, prostitution, pornography, nudity, profanity or other adult content, violence, or the use of alcohol or tobacco products;
  - iii. the taking up of arms against any person, government or entity or otherwise challenge or seek to overthrow any government;
- Must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way;
- Must not contain, facilitate, reference, or use material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, ethnicity, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age; and
- Must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where the Photo was created.

Entrant must have approval from any persons appearing in the Photo and be able to provide express written consent of every such person appearing in the Photo to Sponsor and/or Administrator if requested.

**NOTE:** If any Photo fails to comply with any of these Guidelines and Requirements or any other provisions of these Official Rules, Sponsor/Administrator reserve the right to disqualify the entrant and he/she will not be eligible to win.

**5. RANDOM DRAWING:** On or about June 12, 2019, Administrator will randomly select the potential Sweepstakes winner from among all eligible entries received during the Promotion Period. All selected winners are potential winners, pending verification of eligibility and compliance with these Official Rules, as determined by Sponsor and Administrator, in their sole and absolute discretion.

**6. PRIZES, ODDS OF WINNING, AND APPROXIMATE RETAIL VALUE (“ARV”):**

**A. Instant Win Game Prizes:** There will be eight hundred (800) instant win game prizes. (“Instant Win Game Prizes”). Each Instant Win Game Prize is a coupon for one (1) free Revlon Lip product. The ARV of each Instant Win Game Prize is \$9.99. Total ARV of all Instant Win Game Prizes is \$7,992.

- B. Sweepstakes Grand Prize (1):** The Sweepstakes grand prize is a \$10,000 check. There will be one (1) Grand Prize. The ARV of the Grand Prize is \$10,000.
- C. Total ARV:** The total ARV of all available prizes in the Promotion is \$17,992.
- D. Odds of Winning/Limit:** The odds of winning the Sweepstakes prize depend on the total number of eligible Sweepstakes entries received during the Promotion Period. The odds of winning an Instant Win Game Prize depend on when the entrant completes a Game Play. Instant Win Game Prizes will be made available at random times throughout the Promotion Period. To be a potential winner of an Instant Win Game Prize, an entrant's Game Play must have occurred either at the exact randomly predetermined winning time as determined by Sponsor and/or Administrator. If a Game Play does not occur at the exact randomly predetermined winning time, then the next entrant's Game Play to occur after that time will be deemed a potential Instant Winner. The number of Instant Win Game Prizes available to be won will decrease during the Promotion Period as prizes are awarded and claimed. There is a limit of one (1) Sweepstakes prize and one (1) Instant Win Game Prize per person during the Promotion Period.
- E. General Prize Restrictions:** The use of a gift card/certificate is subject to the terms and conditions set forth thereon which shall govern the use of the gift card/certificate. Use of the gift card/certificate constitutes the user's acceptance of the terms and conditions so the winner should read the terms and conditions on the gift card/certificate carefully. Winners must protect the gift card/certificate and treat the gift card/certificate as he/she would any other valuable document. The gift card/certificate will not be redeemed or exchanged for cash, except where required by law. The gift card/certificate will not be replaced or replenished if it lost, stolen, damaged, destroyed or used without the winner's permission and will be voided if altered or defaced.
- 7. HOW TO CLAIM A PRIZE:** After the random drawing, Administrator will notify the potential Sweepstakes prize winner via e-mail at the e-mail address provided at the time of registration. Before being declared the winner of the Sweepstakes prize, the potential Sweepstakes prize winner will be required to execute an Affidavit of Eligibility/Liability & Publicity Release and tax acknowledgment ("Affidavit"). The potential Sweepstakes prize winner must return a fully executed and notarized Affidavit to the Sponsor or its authorized designee within five (5) calendar days from the date it is postmarked as being sent to the potential winner or the prize may (in Sponsor's sole discretion) be forfeited. All potential prize winners may be requested to provide additional documentation for verification purposes. If the potential Sweepstakes prize winner or a potential Instant Win Game Prize winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a prize, or in the event that the potential winner fails to return any requested documentation or an executed and notarized Affidavit within the five (5) calendar day deadline (if applicable), the prize may be forfeited. If a prize is forfeited, the prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries (or non-winning Game Plays), as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Prizes will be mailed to verified winners at the street address provided at the time of registration within approximately 6 to 8 weeks from the end of the Promotion. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for any prize won. Sponsor will issue an IRS Form 1099-MISC to each winner whose prize is valued at \$600 or more.

Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Promotion e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. The right to receive a prize is non-assignable, non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure, at Sponsor's sole and absolute discretion. Promotion Entities shall not be held responsible for any delays in awarding the prize for any reason.

- 8. LIMITATION OF LIABILITY:** By participating in this Promotion entrants agree that the Promotion Entities and their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers, Web masters and their respective officers, directors, employees, representatives, designees and agents ("Released Parties") are not responsible for lost, late, incomplete, stolen, misdirected, postage due, or undeliverable e-mail notifications or postal mail; or for any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections or availability; or garbled, corrupt or jumbled transmissions, service provider/Internet/Website/use net accessibility, availability or traffic congestion; or any technical, mechanical, printing, or typographical or other error; or unauthorized human intervention; or the incorrect or inaccurate capture of registration information; or the failure to capture, or loss of, any such information. The Released Parties are not responsible for any incorrect or inaccurate information, whether caused by any Website users, tampering, hacking or by any of the equipment or programming associated with or utilized in the Promotion and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Website or any Promotion-related website(s). The Released Parties are not responsible for any injury or damage, whether personal or property, to participants or to any person's computer related to or resulting from participating in the Promotion and/or accepting or using a prize. The Released Parties shall not be responsible or liable for entries that are entered by any automated computer, program, mechanism or device, for any entries in excess of the stated limit or for entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules, and all such entries may, in Sponsor's sole discretion, be disqualified.

If, for any reason, the Promotion is not capable of running as planned, Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Promotion and/or proceed with the Promotion, including the selection of winners in a manner it deems fair and reasonable including the selection of the winners from among eligible Game Plays/Sweepstakes entries received prior to such cancellation, termination, modification or suspension. In no event will more prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winners. If for any reason, including but not limited to an administrative, printing, production, computer or other error or due to technical difficulties or incorrect announcements of any kind, more winning messages are distributed, or more prizes are claimed than are intended to be awarded according to these Official Rules, the intended prizes will be awarded in a random drawing from among all verified prize claims received.
